HIGHLIGHTS FROM THE DESK



PRESIDENT/CEO

An Orlando Sentinel Newspaper published an article regarding the site planning for Griffin Park Apartments, Orlando Housing Authority's oldest public housing complex. The article focused on the impact of the I-4 and 408 Expressways that completely surround Griffin Park. While researching the history of Griffin Park to answer the Reporter's questions, I found information regarding the History of Public Housing in a report prepared for the Orlando Housing Authority by Janus Research in June 2001. I found the information thoroughly fascinating. I decided to share excerpts from the Janus Report in a series of reprinted excerpts.

"....The move for a federal housing program had its beginnings in the late nineteenth century and was sparked by the substandard living conditions of workers in tenements in major cities such as New York. A fear of government involvement in the real estate market fueled the opposition to

such a program, and it was not until the 1910s that the Federal government initiated actions that i8mpacted the housing situation although hot specifically addressing the issue. In 1918, the first federal housing initiative was undertaken when housing shortages were believed to be impacting the war effort. This led to the passage of legislation that authorized the United States Shipping Board to initiate housing programs a shipbuilding centers. Although this was considered necessary for national defense, it was nonetheless, controversial because it was considered by the opposition as a "stepping stone" toward permanent legislation. Indeed, the initiation of this law did provide the beginnings of a federal program that culminated in two substantial housing programs, the Public Works Administration (PWA) in 1933 and the United States Housing Act of 1937 (also know as the Wagner-Steagall Act). The PWA Limited-Dividend Housing Program authorized low-interest loans to limited dividend housing corporations (Robinson et at 1999: Volume II, Page 13). In February of 1934, the Public Works Administration Limited-Dividend Housing Program was suspended and the Direct-Built Housing Program was established, in which the Public Works Administration would acquire the land, let contracts for slum clearance and construction, and own and operated the completed housing (Robinson et al 1999: Volume II, Page 18). In Florida, two Public Works Administration projects were completed Durkeeville in Jacksonville and Liberty Square in Miami."

It is ironic that I came to Orlando from Miami where I worked all around Liberty Square. It is like running into an old friend.






JOHNSON MANOR'S ANNUAL CHRISTMAS EVENT

HUD AWARDS \$2.9 MILLION TO FLORIDA TO FIGHT HOUSING DISCRIMINATION

MIAMI - The U.S. Department of Housing and Urban Development today awarded \$2,998,306 to six fair housing organizations in Florida in an effort to reduce housing discrimination. This funding is part of \$38.3 million HUD awarded today to 95 fair housing organizations and other non-profit agencies in 38 states.

Funded through HUD's *Fair Housing Initiatives Program (FHIP)*, these grants will help enforce the Fair Housing Act through investigation and testing of alleged discriminatory practices. In addition, the funds will educate housing providers, local governments and potential victims of housing discrimination about their rights and responsibilities under the Fair Housing Act.

"Ending housing discrimination requires that we support the law of the land and protect the housing rights of individuals and families who would be denied those rights," stated HUD Secretary Shaun Donovan. "Ensuring and promoting Fair Housing practices lies at the core of HUD's mission and these grants enable community groups all over the nation to help families who are denied equal access to housing."

Ed Jennings, Jr., the HUD Southeast Regional Administrator, added: "No one should be denied the opportunity to live where they want because of how they look, their faith, whether they have children or because they have a disability. These grants will help us continue our efforts to educate the public and housing industry about their housing rights and responsibilities."
